EXAMINING THE IRS RESPONSE TO THE TARGETING SCANDAL

The IRS has the authority to change its internal policy at any moment, which means it can remove the
problematic rules at its discretion. Doing so would eliminate the agency procedure that enabled the targeting
scandal. To date, the agency has not made the required changes to its rules.

former IRS official Lois Lerner, is still in charge of the agency.
