A legal nurse consultant (LNC) is a registered nurse who uses expertise as a health care provider and specialized training to consult on medical-related legal cases. LNCs assist attorneys in reading medical records and understanding medical terminology and healthcare issues to achieve the best results for their clients. The specialty is a relatively recent one, beginning in the mid-1980s.
